

- 10. The Managing Trustee during the life time shall name the successor to the Managing Trustee and on his failure to do so, may be appointed by the Board of Trustees, on such terms and conditions as the Managing Trustee or as the case may be the Board of Trustees deem fit.
- 11. The Managing Trustee shall have overall power of superintendence over the affairs of the Trust and shall have in particular, the power to operate bank accounts, borrow monies for the Trust from the bankers, execute all documents in connection with such operations and carry out the objects of the Trust Connection with such operations and carry out the objects of the Trust Connection with such operations.
- 12. Proper Assounts for the Trust shall be year ending \$1" March. The Financial Statements and affairs of the Trust as on \$1" March of each year shall be audited by a factored Accountant or Chartered Accountants and the audited reports shall be signed by all the trustees. - 13. The initial contribution of Rs.5,000/-(RUPEES FIVE THOUSANDS ONLY)
 made by the author of the Trust shall hereby vest in the Trustees and shall
 constitute the fulfal Trust Fund.

- 14. The Trust Fund may be augmented by the income from the initial fund and also the donations and other contributions from time to time.
- 15. The funds of the Trust shall not be applied for any purpose other than the objects of Trust stated in para 16 on page 4.
- 16. The Objects of the trust are:
 - a. To open, run, continue educational and vocational institutions in healthy surroundings.
 - To establish, maintain and run a boarding house and residential accommodation for students and those connected with the institution.
 - c. To develop a healthy as well as critical attitude towards the development of mental, physical, and moral uplift of the students and those connected with the institution so as to make them good citizens.
 - d. To accept effis, donations either in form of monies or any kind or by way of immovable properties from person either resident of India or in any foreign countries and to deal with the same for the purpose of the Trust.

- e. To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.
- To train and equip the pupils so as to be self-supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.

g. To develop discretionary conduct and a habit to observe the rule of law and self-restraint.

- To bring out, encourage and develop and inventive and research faculties of the pupils and teachers and to afford opportunity for research work in art, science and industrial undertakings.
- L To promote and bring out re-marriage of widows and to meet the expenses therefor and to provide an institutional support for achieving the said object.
- To give orphans monetary or institutional help for their higher education in science, art and or in any other professional courses or for pursuing higher studies in India or in any other foreign countries.
- To establish home for aged and invalid in different centres in Tamil Nadu.
- The Trust may also run a women section to impart education technical or social studies.
- m. The Trust to run and Maintain Hospitals.
- n. The Trust to establish industries to uplift downtrodden and
 Backward classes people by offering them training and employment.
- To establish community halls open to public, to conduct meetings, Seminars, marriages etc., on nominal charges.
- 17. Rules may be framed for the proper administration of the trust, but such Rules shall not be against the objects of the trust as in clauses 16 above.
- 18. For the removal of doubts it is hereby declared that this trust, its objects and its implementation shall not be for the benefit of any Particular caste or religious community as stich.
- 19. The Board of Trustees shall have the power to acquire immovable or movable properties for the trust and likewise the power to sell, Lease or mortgage or otherwise deal with such properties.
- 20. The Board of Trustees shall meet as often as may be necessary or convenient to transact business. The board of trustees might transact business and take decisions also by circulation of papers.
- 21. All decisions of the board of trustees shall be taken either unanimously or by majority and if the board is equally divided, The managing trustee will have the casting vote.
- 22. Without prejudice the powers of the Board of Trustees the Managing Trustee shall manage and administer the affirs of the trust and shall also exercise such power and function as may be delegated to him by the board of trustees.

- The Management and administration of the trust shall vest in the Board of Trustees.
- 24. The fends of the trust shall be invested in Bank Deposits, Government bonds or such other appropriate security as the Board of Trustees may decide.
- 25. The Board shall have power to borrow monies for the purposes of the trust.
- 26. The trustees may also get or take remuneration for their service to the trust and to the extent of service thereunder. They are en-clied for remmuneration in consistance with the service and all such other actual expense incurred by the trustees, the trustees are empowered to reimburse the same from the trust fund. The management and control of the trust property shall be rested with the trustees.
- 27. Without prejudice to the generality of the provisions of contained above the Board of Trustees may also empower the Managing Trustee to represent or act for the trust in any matter concerning the properties, funds investments for any of these purposes.
- 28. The Managing Trustee may authorise any of the trustees to at on his behalf and to operate Bank accounts etc.
- 29. The Managing Trustee shall have power to form an Executive Committee and to appoint personnel and consultants to organize and promote the objects of the trust and to regulate their Conditions of service, including matters of discipline.
- 30. All Acts and proceedings of the trust shall be taken and conducted in the name of the trust.
- 31. This trust is krevocable.
